

Terms and Conditions (Exclusive)

LICENSING TERMS

BY CONFIRMING YOUR PURCHASE AT CHECK OUT YOU HEREBY COMPLY WITH ALL LICENSING TERMS. YOU UNDERSTAND THAT THE TERMS CANNOT BE ALTERED OR MANIPULATED IN ANY WAY, SHAPE, OR FORM AFTER PURCHASE. NO REFUNDS WILL BE GIVEN ONCE THE FILES ARE SENT. ANY UNAUTHORIZED CHANGES MADE TO THESE AGREEMENTS WILL VOID THEM. ANY CHARGEBACKS WILL VOID THESE AGREEMENTS. THE LICENSORS' (PinkSpryteProductions) INTERPRETATION OF THESE TERMS (AND/OR AGREEMENTS) OVER RULE ANY OTHER INTERPRETATIONS.

EXCLUSIVE RIGHTS | Receive WAV Trackouts, High Quality MP3 File & High Quality WAV File
Master Recording/Distribution: The Licensor hereby grants the Licensee full artistic and commercial rights to the purchased beat. There is no sales cap related to exclusive rights. The Licensee is allowed to sell his/her song over the beat-composition without any sales limitation, worldwide. The Licensee is granted unlimited commercial use for the song created. The Licensee is permitted to keep 100% of the profit made from the song created. Licensee is not allowed, nor has the authority, to dis-allow/forbid other non-exclusive license-owners any use of the beat-composition(s) for commercial/profitable purpose or take any legal actions against non-exclusive license owners. The Licensor forbids the licensee to re-sell or distribute the Instrumental, either as they exist or any modification thereof. The Licensee can not sell, loan, rent, lease, assign, remix, rearrange, remove any melodies, instruments, drum programming or transfer rights to another user (example - Record Label, another production company, another producer), or for use in any competitive product without written consent and or another license agreement.
Previous Non-Exclusive Purchases: If previous leasing rights have been sold before the beat has been sold exclusively, they are not affected and stay valid until the sales cap has been reached. License owners of non-exclusive rights may upgrade their current non-exclusive license to a higher non-exclusive license (if available). It is therefore possible that a beat has been leased several times before exclusive rights are sold.
Ownership: The licensee understands that the licensor maintains 100% copyright and ownership of the original instrumental composition and that licensee buys exclusive sales rights and rights of use to the beat-composition(s) but not the intellectual property itself. This is necessary and entitles licensor to maintain the administrative and legislative rights to the beat-composition, in order to be able to ensure non-exclusive license owners administrative guidance and license-warranties. Licensee can use song(s) over beat compositions as background element in TV, Film and DVD / computer game projects without obtaining written consent and/or another license agreement. The licensor maintains full rights to mix, rearrange, alter, add or remove sounds, drum programming and/or melodies to form a new beat composition. Once exclusive rights are sold, nobody else (including but not limited to - person, entity such as a business, record label etc.) will be able to purchase the same exact instrumental composition.
Credit: Licensee must include on all productions, products and any medium the producer's name (Calibaset or LewisYouNasty). Licensee agrees to display the producer's name in all physical media or within web presentations or sum of the original instrumental composition that is being licensed in this agreement. Including but not limited to CD's, CD covers, Booklets, Cassette tapes, LP's, Cards, Cases, Boxes, etc.
Samples: If the Instrumental includes samples, the Licensee understands that the sequence and music arrangement is considered original work. Samples may not have been cleared before composition, and Licensee is required to seek clearance for the samples. The Licensee is responsible for clearing all samples used (if any) and that the Licensor cannot and will not be held liable for the misuse of any sampled material that the Licensee uses in conjunction with the composition/arrangement that is being licensed in this agreement.

Upon request, an exclusively sold beat may be removed from any website and marketing space where it has been offered for sale by the licensor, if licensor agrees to. This excludes demonstration videos (e.g. youtube, etc.) or demonstration audio material used in intros, animations or as background music.

Any arbitration under these Terms and Conditions will take place on an individual basis; class arbitrations and class/representative/collective actions are not permitted. THE PARTIES AGREE THAT A PARTY MAY BRING CLAIMS AGAINST THE OTHER ONLY IN EACH'S INDIVIDUAL CAPACITY, AND NOT AS A PLAINTIFF OR CLASS MEMBER IN ANY PUTATIVE CLASS, COLLECTIVE AND/ OR REPRESENTATIVE PROCEEDING, SUCH AS IN THE FORM OF A PRIVATE ATTORNEY GENERAL ACTION AGAINST THE OTHER.
